Above approval will be based on the Fulfillment of below-mentioned terms and conditions .


1. School will abide by the free And compulsory education for children act 2009 (Annexure 1) and the Maharashtra Right of Free and Compulsory Education for children Rules 2011 (Annexure 2).
2. School will admit children belonging to the weaker section and Disadvantage group in class(Std) I up to the minimum of 25% of the number of students in that class and provide them free and compulsory education till the completion of primary education .
3. For the children specified in paragraph 3 the school shall receive reimbursement in accordance with section 12 (2) of the act. A separate bank account will be provided to the school for such reimbursement.
4. The school will not charge any capitation Fee for any method or scrutiny or force child or his parents
5. No child shall be denied admission to a school due to lack of proof of age, Religion, caste or ethnicity, Place of birth or any of these reasons .
6. (one) No child admitted to a school shall be held in the same class as he or She is or shall not be expelled From school till the Completion of primary education.
7. (two) No child Shall be Subjected to Corporal punishment for mental torture .
(three) No child shall be required to pass any board examination till completion of primary education.

(Four) Certificate prescribed under Rule 23 will be issued to the child who has completed Primary education.

(Five) Students with disabilities / special needs will be included as per the provisions of the act.

(Six) Teachers with the minimum qualifications prescribed under section 23 (1) of the Act shall be appointed. However, teachers who do not meet the minimum qualification on the date of commencement of the Act will have to acquire such minimum qualification within a period of 5

cars. (Seven) The school shall ensure that the teacher shall perform his / her duties specified in section 24 (1) of the act and.

9.The school is being run by an organization registered under the society Registration Rules 1860 (21 of 1860) or the Mumbai Public Trusts Act, 1950


10.The school is not run for the benefit of any person ,group or individual or any other person or for any profit.



आपल्या अर्जाच्या संदर्भात आणि त्यानंतर यासंदर्भात शाळांशी केलेला पत्रव्यवहार / शाळेची केलेली तपासणी याआधारे. मी शिक्षणाधिकारी (प्राथमिक), पुणे जिल्हा परिषद, पुणे दिनांक- 1 एप्रिल 2019 पासून ते दिनांक 31 मार्च 2022 पर्यंतच्या कालावधीसाठी इ.1 ली ते इ.8 वी साठी कॅम्प एज्युकेशन सोसायटी,कॅम्प पुणे संचलित मोतीलाल तालेरा इंग्लिश मिडीयम स्कुल, प्लॉट नं-3, सेक्टर नं.4 पिंपरी चिंचवड ता.हवेली,जि.पुणे तात्पुरती मान्यता देत आहे.

वरील मान्यता ही खालील शर्तीच्या पूर्ततेच्या अधीन आहे.

मान्यतेचा कालावधी वाढवून मिळणार नाही आणि इयत्ता आठवीनंतर मान्यता किंवा संलग्नता देण्यास कोणतेही बंधन नसेल.

- 1.बालकांना मोफत व सक्तीच्या शिक्षणाचा अधिनियम 2009(जोडपत्र एक) आणि महाराष्ट्र बालकांना मोफत व सक्तीच्या शिक्षणाच्या हक्क नियम 2011 (जोडपत्र दोन) शाळा पालन करील.
- 2.शाळांना नजिकच्या दुर्बल घटकातील आणि वंचित गटातील बालकांना पहिल्या इयत्तेत त्या इयत्तेतील विद्यार्थी संख्येच्या किमान 25% मर्यादेपर्यंत प्रवेश देईल आणि प्राथमिक शिक्षण पूर्ण होईपर्यंत त्यांना मोफत व सक्तीचे शिक्षण देईल परंतु आणखी असे की, पूर्व प्राथमिक इयत्तांच्या बाबतीतदेखील या प्रमाणे अनुपालन करण्यात येईल.
- 3.परिच्छेद 3 मध्ये निर्दिष्ट केलेल्या बालकांकरिता शाळेला अधिनियमाच्या कलम 12(2) नुसार प्रतिपूर्ती मिळेल. अशी प्रतिपूर्ती मिळण्यासाठी शाळेला स्वतंत्र बँक खाते देण्यात येईल
- 4.संस्था/शाळा कोणतेही कॅंपिटेशन फी वसूल करणार नाही आणि कोणत्याही छाननी पध्दतीसाठी बालकास किंवा त्यांच्या किंवा त्यांच्या मात्या-पित्यास किंवा पालकास भाग पाडणार नाही.
- 5.कोणत्याही बालकास वयाच्या पुराव्याच्या अभावी, धर्म,जात,किंवा वंश,जन्मठिकाण किंवा यापैकी कोणत्याही कारणास्तव,शाळेमध्ये प्रवेश नाकारता येणार नाही.
- 6(एक) शाळेत प्रवेश दिलेल्या कोणत्याही बालकास तो ज्या इयत्तेत असेल त्याच इयत्तेत रोखून ठेवले जाणार नाही किंवा प्राथमिक शिक्षण पूर्ण होईपर्यंत शाळेतून काढून टाकण्यात येणार नाही.
- 7(दोन)कोणत्याही बालकास शारीरिक शिक्षा किंवा मानसिक त्रास देण्यात येणार नाही.

(तीन)कोणत्याही बालकास प्राथमिक शिक्षण पूर्ण होईपर्यंत कोणत्याही मंडळाची परिक्षा उत्तीर्ण होणे आवश्यक असणार नाही.

(चार)प्राथमिक शिक्षण पूर्ण केलेल्या बालकास नियम 23 अन्वये निर्धारित केलेले प्रमाणपत्र देणेत येईल.

(पाच)विकलांग / विशेष गरजा असलेल्या विद्यार्थ्यांचा अधिनियमाच्या तरतुदीनुसार समावेश करणेत येईल.

(सहा) अधिनियमाच्या कलम 23(1) मध्ये अन्वये निर्धारित केलेली किमान अर्हता धारण करणाऱ्या शिक्षकांच्या नियुक्ती करण्यात येईल. परंतु आणखी असे की, अधिनियमाच्या प्रारंभाच्या दिनांकास किमान अर्हता धारण न करणाऱ्या शिक्षकांना अशी किमान अर्हता 5 वर्षांच्या कालावधीत संपादित करावी लागेल.

(सात) अधिनियमाच्या कलम 24(1) मध्ये विनिर्दिष्ट केलेली त्यांची / तिची कर्तव्य शिक्षक पार पाडतील आणि (आठ) शिक्षकाने / शिक्षिकेने खाजगी शिकवणीच्या कामात स्वतःला गुंतवून घेऊ नये, याची सुनिश्चिती शाळा करेल
